Wyoming Oil and Gas Fair Policies - Terms and Conditions

What to expect if you are an exhibitor or attendee

Exhibitors - Booth Rental

You will pay \$1,000 booth rental fee, which includes - 2 tickets for you booth and 5 complimentary tickets to be give out to your customers. Other persons occupying your booth will need to pay \$25 each for a vendor registration ticket. You will have a 10' X 10' booth that is piped and draped. It will be equipped with one six-foot table and two chairs. Electricity and wireless internet access will be provided. All other equipment/needs will be supplied/purchased from the Casper Events Center.

Attendees/Exhibitors

You will pay \$75 for one attendee/vendor registration ticket. Breakfast sandwiches/burritos will be served both days. Lunch on Wednesday will consist of croissant sandwiches and chips as well. Both breakfasts and lunch will have sit down seating on the floor of the Events Center. Our reception on Wednesday night will have an open bar and LOTS of yummy hors d'oeuvres held at the Beacon Club. You may attend all the speakers' presentations on Wednesday and Thursday. You can also view all the exhibitors' booths.

Shipping and/or Handling Policy

Please note: there are NO shipping and/or handling charges involved. All actions are intangible.

Exhibitor's Issues Policy

Exhibitors having issues with other companies/competitors have two (2) options: 1) Get along with competitor. 2) Cancel their booth space.

The \$75 personal/booth occupant registration fee will be refunded if written notice requesting same is received by NOON August 31th, 2017.
